**August 05, 2022** – Progress report provided to the NMCAL Directors.

**August 22, 2022** – Submitted acceptance letter to NMLA for presenting at the October 2022 Conference. Combined presentation will focus on Library GO Bonds informing and spending. Presentation accepted and is on the NMLA program for Thursday, October 27, 2022 from 2:00pm-2:50pm.
